



### New Cases/Hospitalizations By CDC Week





WHEREAS, on March 13, 2020, the Governor of the State of Texas declared a state of disaster and the President of the United States of America declared a national emergency in relation to COVID-19; and

**WHEREAS**, on March 13, 2020, the Mayor signed a Local Emergency Declaration and requested the aid of the State Government pursuant to Texas Government Code Section 418.108; and

**WHEREAS**, pursuant to El Paso City Code Section 2.48.020(C), a local state of disaster declaration may not be continued or renewed for a period in excess of seven days except by or with the consent of City Council; and

**WHEREAS**, City Charter Section 3.10 allows for the City Council to adopt an emergency ordinance to meet a public emergency affecting life, health, property or the public peace; and

**WHEREAS**, on March 17, 2020, the City Council adopted Emergency Ordinance No. 019035, Extending a Disaster Declaration Due to a Public Health Emergency; and

**WHEREAS**, since March 2020, El Paso City Council has re-enacted Emergency Ordinance No. 019035 monthly, with the most recent re-enactment taking place on September 13, 2021; and

**WHEREAS**, as of September 30, 2021, the number of COVID-19 active cases in El Paso is over 1,489; and

**WHEREAS**, pursuant to City Charter Section 3.10, every emergency ordinance shall stand repealed automatically as of the 31<sup>st</sup> day following the date on which it was adopted, but may be re-enacted to continue a Disaster Declaration; and

**WHEREAS**, Emergency Ordinance No. 019228 which re-enacts Emergency Ordinance No. 019035 is set to expire on October 13, 2021; and

**WHEREAS**, the condition necessitating a declaration of a state of disaster continues to exist.

### NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF EL PASO, TEXAS:

- 1. That the state of disaster proclaimed for the City of El Paso by the Mayor on March 13, 2020, and extended by Emergency Ordinance No. 019035, is hereby re-enacted and shall continue for thirty (30) days unless re-enacted in accordance with City Charter Section 3.10 or until terminated by City Council, whichever is sooner.
- 2. This ordinance is adopted as an emergency measure with the unanimous vote of the City Council Representatives present and the consent of the Mayor and pursuant to City Charter Section 3.10.

**WHEREAS**, pursuant to City Charter Section 3.10, every emergency ordinance shall stand repealed automatically as of the 31<sup>st</sup> day following the date on which it was adopted, but may be re-enacted if the emergency still exists; and

**WHEREAS**, a disaster continues to exist and requires that certain emergency measures be taken to meet a public emergency affecting life, health, property or the public peace; and

WHEREAS, the City Council desires to re-enact Emergency Ordinance No. 019036, as re-enacted, restated and amended on March 16, 2021 through Emergency Ordinance No. 019151, as further re-enacted and amended on March 29, 2021 through Emergency Ordinance No. 019156, as further re-enacted and amended on April 26, 2021 through Emergency Ordinance No. 019169, as further re-enacted and amended on May 24, 2021 through Emergency Ordinance No. 019191, which shall remain in effect for thirty days or until otherwise terminated, re-enacted, or superseded by a conflicting El Paso Local Health Authority order, or state or federal law or order.

#### NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF EL PASO, TEXAS:

- 1. Emergency Ordinance No. 019036, as re-enacted, restated and amended by Emergency Ordinance No. 019151, and as further re-enacted and amended by Emergency Ordinance Nos. 019156, 019169, and 019191, penalty as provided in Section 8, is hereby re-enacted.
- Emergency Ordinance No. 019036, as re-enacted, restated and amended by Emergency Ordinance No. 019151, and further re-enacted and amended by Emergency Ordinance Nos. 019156, 019169, 019191, penalty as provided in Section 8, shall remain in full force and effect and continue for thirty (30) days unless re-enacted in accordance with City Charter Section 3.10 or until terminated by the City Council, whichever is sooner.

March 17, 2020, El Paso City Council adopted Emergency Ordinance No. 019035 extending the City's Disaster Declaration due to a Public Health Emergency. Also on, March 17, 2020, El Paso City Council reenacted its Emergency Ordinance extending the City's Disaster Declaration monthly, with the most recent extension taking place on August 31, 2020.

August 31, 2020, El Paso City Council adopted Emergency Ordinance No. 019091, which suspended various sections of the El Paso City Code to facilitate temporary uses on the public right of way and private property and established a pilot program.

September 28, 2020, El Paso City Council enacted an Emergency Ordinance Re-Enacting Emergency Ordinance No. 019091.

October 27, 2020, El Paso City Council enacted an Emergency Ordinance Re-Enacting Emergency Ordinance No. 019091. Also, City Council approved increasing the fine for all emergency directive violations from \$500 to \$1,000.

WHEREAS, on March 13, 2020, the Governor of the State of Texas declared a state of disaster and the President of the United States of America declared a national emergency in relation to COVID-19; and

**WHEREAS**, by proclamation issued on March 13, 2020, the Mayor declared a local state of disaster for the City of El Paso resulting from a public health emergency; and

**WHEREAS**, on March 17, 2020, El Paso City Council adopted Emergency Ordinance No. 019035 extending the City's Disaster Declaration due to a Public Health Emergency; and

**WHEREAS,** since March 2020, El Paso City Council has re-enacted Emergency Ordinance No. 019035 monthly basis, with the most recent re-enactment taking place on January 5, 2021; and

**WHEREAS,** Governor Abbott has similarly renewed the State's COVID- 19 Disaster Declaration, with the most recent extension taking place on January 5, 2021; and

**WHEREAS**, El Paso City Charter Section 3.10 allows City Council to adopt an emergency ordinance to meet a public emergency affecting life, health, property, or the public peace; and

WHEREAS, the El Paso City Council desires to support restaurants and similar establishments in their efforts to safely operate during the COVID-19 pandemic by further facilitating outdoor service and dining opportunities; and

**WHEREAS**, to that end, the El Paso City Council hereby suspends various sections of the El Paso City Code to facilitate temporary uses on the public right of way and private property.

# NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF EL PASO, TEXAS:

#### SECTION 1. SUSPENSION AND MODIFICATION OF ORDINANCES.

- B. Any other provisions of the El Paso City Code not mentioned above that may govern the temporary uses described in Section 2(B) below are also suspended.
- C. Any of the aforementioned provisions that do not apply to the temporary uses on public right of way and private property identified in Section 2(B) below as permitted by this Emergency Ordinance are not suspended or amended, and remain in full force and effect.

#### SECTION 2. ESTABLISHMENT OF A PILOT PROGRAM.

A. The City Manager or designee ("City Administration") has created temporary requirements, application, and permit to allow/facilitate the temporary uses described in Section 2(B) below for the duration of this Ordinance ("Pilot Program"). Any persons wishing to use public right of way or private property for any temporary uses allowed under Section 2(B) below must submit an application, receive a permit, and abide by all the requirements of this Ordinance and the permit. It is a violation of this Ordinance for a person to use public right of way or private property for any temporary uses described in Section 2(B) below in violation of the requirements of this Ordinance and the permit. It is a violation of this Ordinance for a person to use public right of way or private property for any temporary uses described in Section 2(B) below in violation of the requirements of this Ordinance and/or an issued permit.

- B. The following are the temporary uses allowed under the Pilot Program:
  - 1. Safe Streets. "Safe Streets" means the occupation of a portion of the public right of way that is currently used as on-street parking and/or automobile traffic that shall be utilized for additional outdoor public space. This space shall be used for the following purposes:
    - a. Ped-Way (Pedestrian Lane): "Ped-Way (Pedestrian Lane)" means the use and occupation of an area that is to be utilized for outdoor recreational purposes, including but not limited to, pedestrian movement, bicycling, and/or Shared Use Mobility Devices.
    - b. ROW Café: "ROW Café" means the use and occupation of an area that is to be utilized for businesses to provide additional space for outdoor dining and seating, space for patrons, and merchandise, which encompasses a partial street closure of the entire block, which may or may not include onstreet parking, directly fronting only their establishment.
    - c. Parking-parklet: "Parking-parklet" means the use and occupation of an area that is to be utilized for businesses to provide additional space outdoor dining and seating, space for patrons, and merchandise, which encompasses on-street parking spaces directly abutting only their establishment.
    - 2. Safe Business. "Safe Business" means the use and occupation of a portion of private property that is currently used as off-street surface parking spaces serving the abutting commercial establishment shall be utilized for additional outdoor dining space, outdoor queuing, and order pick-up and drop-off serving only their establishment.
    - 3. Safe Food Court. "Safe Food Court" means the use and occupation of a portion of public right of way or the occupation of a portion private property currently used as shared off-street parking, that is to be utilized and shared by multiple restaurants and/or food trucks for the purpose of outdoor dining and seating, which may or may not abut their establishment.
- C. Notwithstanding anything to the contrary, the requirements created by City Administration for the Pilot Program must require all applicants and participants:
  - 1. To follow all applicable local, state, and federal orders and guidelines issued by the Centers for Disease Control pertaining to COVID-19,
  - 2. Continue to allow for the passage of pedestrian traffic at all times,
  - 3. Not allow encroachment into handicap parking/ramps or otherwise reduce the ADAAA accessibility of the site,
  - 4. Require ADAA compliance for access to the outdoor area,

- 5. Not impede flow from building exits,
- 6. Be in compliance with any fire and safety ordinances,
- 7. Be in compliance with TABC rules and regulations,
- 8. To indemnify, defend, and hold harmless the City for all claims resulting from the applicant's and/or the applicant's employees', contractors', licensees', and/or invitees' use of public right of way or private property for temporary uses,
- 9. To release the City from all claims related to the applicant's use of public right of way or private property for temporary uses,
- 10. To pay for any damage caused to the public right of way caused by the applicant or the applicant's employees', contractors', licensees', and/or invitees'.
- D. The City Attorney's Office is authorized to grant waivers of requirements in Section 2(C) (8), (9), and (10) above.
- E. All persons and businesses wishing to use the right of way or private property as described in the Pilot Program must comply with the requirements herein as well as any requirements established by City Administration for the Pilot Program.

#### **SECTION 3. LIMITATIONS**

- A. The provisions suspended by this ordinance remain applicable to any temporary uses not addressed by the Pilot Program. Any person wishing to use public right of way or private property not subject to the Pilot Program must comply with all requirements of the El Paso City Code.
- B. Nothing in this ordinance grants any permanent rights to any person pertaining the right of way. Nothing in this ordinance limits the City's control over municipal rights of way. Nothing in this ordinance constitutes a vacation of any portion of the public right of way.
- C. Nothing in this Ordinance allows for any permanent uses of the right of way.
- D. All authorizations to use the public right of way or private property under this Ordinance and/or the Pilot Program are revocable at any time for any reason at the sole discretion of the City Administration for the City of El Paso.

#### SECTION 4. ADMINISTRATIVE TERMINATION OF PILOT PROGRAM

Due to the uncertainty caused by this pandemic, the City Administration is authorized to terminate the Pilot Program and any uses of public right of way or private property under this order

if in the discretion of City Administration such termination is necessary for the health, safety, or welfare of the community. If City Administration terminates the Pilot Program, then all City Code provisions suspended under this order are reinstated as of the date of termination of the Pilot Program.

#### SECTION 5. DURATION OF SUSPENSION

The suspension or modification of the ordinances and regulations listed herein shall remain in effect for 30 days, unless re-enacted in accordance with City Charter Section 3.10 or until the state of disaster is terminated, whichever is sooner.

#### **SECTION 6. PENALTIES**

- A. These regulations shall have the effect of ordinances when duly filed with the City Clerk.
- B. A person who violates any provision of these regulations and/or the requirements established by the City Administration pertaining to the Pilot Program under this Ordinance, upon conviction, is guilty of a misdemeanor punishable by a fine of not more than \$1,000.00.

#### SECTION 7. SEVERABILITY CLAUSE.

It is hereby declared to be the intention of the City Council that phrases, sentences, paragraphs and sections of this ordinance are severable. If any part of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect the remaining phrases, sentences, paragraphs and sections.

#### **SECTION 8. EMERGENCY.**

- A. This emergency ordinance is adopted as an emergency measure with the unanimous vote of the City Council Representatives present and the consent of the Mayor pursuant to City Charter Section 3.10.
- B. This emergency ordinance shall take effect immediately upon its adoption and publication and it is accordingly so ordained. This ordinance shall remain in effect for 30 days, unless re-enacted in accordance with City Charter section 3.10 or until a state of disaster is terminated, whichever is sooner.





### City created the PSB for water & wastewater

- In 1952, the City Council transferred complete authority and control of the management and operation of the water and wastewater system to the Public Service Board (Ordinance 752) by vesting them with "complete management and control of the system.... with the same freedom and in the same manner as are ordinarily enjoyed by the Board of Directors of a private corporation operating properties of a similar nature."
- Per bond ordinance, the Board has complete management of its infrastructure, land assets and has the same authority with respect to El Paso Water employees as that of the City Council with respect to employees of the City.





### **50-Year water plan approved by TWDB**


- 1991: EPWater started producing 50-Year Water Plans to anticipate and plan to meet community water needs.
- 1995: Texas legislature designated the PSB as the regional water and wastewater authority and planner (SB 450)
- 1997: Texas legislature adopted current water planning process with 16 water planning areas; El Paso is part of Region E (Far West Texas Planning Group).
- Every 5 years: Every water utility, county and all 16 regions conduct planning exercises, evaluate population growth and water demands and available supplies to update their plans.
- 2021: EPWater submitted its latest updated 50-Year plan as part of the Region E Plan. TWDB has approved it.



The City is invited and encouraged to attend Region E planning meetings, which typically meet quarterly. City was previously but not currently active.


### El Paso's Water Sources: Typical vs. 2070




### **EPWater payments to the City**







## Chronic staffing shortages in customer service

EPWater receives more than 380,000 customer calls each year but struggles with volume.

- Salaries cannot compete with private call centers. EPWater becomes training ground for many customer service call-takers, and then they move on.
- EPWater has 34 customer relations positions; currently 79% staffed.
   Nearly year-around postings, hiring and training
   16 departures and 25 new hires this year

## **History of EPWater land acquisition**

- Ratepayer money was used to purchase the lands in which EPWater is a trustee.
- Land was purchased specifically for groundwater rights and spacing of wells. Money generated from land sales was/is applied to the CIP.
- Under the rules, only the lands not needed for the water, wastewater and stormwater system can be sold.

## **Partnerships to preserve lands**



EPWater transferred 12,000 acres (half the park's total acreage) to Texas Parks and Wildlife.



EPWater acquired the 372-acre Rio Bosque Wetlands Park. Managed by UTEP-CERM with help from Friends for the Rio Bosque.



## **OSAB** and open space priorities

Ordinance specifies that 10 percent of stormwater system's annual utility fee be allocated for green projects with stormwater benefit.

- Total open space acreage purchased: 515.7 acres
- EPWater uses the 10% set-aside from stormwater fees to purchase and preserve open space to improve flood protection.
- Open Space Advisory Board (OSAB) is charged by Council to prioritize open space acquisitions, and we strictly follow OSAB priorities.
  - Per ordinance, park ponds are also prioritized
  - Council/constituent feedback on open space priorities should go to OSAB.
- EPWater is supportive of preservation and conservation easements, but there are occasions when it's not an option.
  - Example: If state owns mineral rights, state must sign off



## Management of open space

- Ordinance Language: ".... the Board shall take into account the use of open space as natural drainage and to extent reasonably possible preserve the City's open spaces, greenways, arroyos and wilderness areas in their natural state as a means to assist in the management of stormwater and in accordance with the City's Open Space Master Plan."



## **Streets and Capital Improvement coordination**

- We have an engineering manager who meets with Streets monthly to discuss street resurfacing projects and EPWater replacement projects within Streets projects.
- We have meetings with Capital Improvement team and their consultants at 30%, 60%, 95% design.
- On projects in construction, we have weekly Capital Improvement meetings.
- Water and wastewater plans are submitted to the City for the City's Bid package for streets projects

## **OEM and emergency coordination**

- EPWater has an employee who sits at the EOC during emergencies, who is linked into the alert bulletins put out by OEM and has access to OEM information systems.
- EPWater's representative provides briefings to OEM via email, phone, or in person, as required by individual situations or requested by EPWater management.
- EPWater participates in OEM exercises.

## **Partnership with Fort Bliss**

- Collaboration with Public Works Department on joint priorities to preserve health and resilience of the installation.
- Recently signed an Intergovernmental Services Agreement, enabling the utility to provide a range of water engineering and water planning services for Fort Bliss.
- KBH Desalination Plant is on Fort Bliss property and helps meet water resiliency needs of the base.
- EPWater provides 25% of water needs to installation; Fort Bliss Water (private) provides 75%.
- EPWater provides 100% of wastewater needs to installation.



## UPDATE ON THIRD SPECIAL SESSION AND FUTURE SPECIAL SESSIONS

Governor identified 7 items he wanted addressed.

1. Legislation identical to Senate Bill 29 as passed by the Texas Senate in the 87th Legislature, Regular Session, disallowing a student from competing in University Interscholastic League athletic competitions designated for the sex opposite to the student's sex at birth.

SB 3 relating to requiring public school students to compete in interscholastic athletic competitions based on biological sex, passed in the Senate and was referred it to Public Education House Committee.
HB 25 relating to requiring public school students to compete in interscholastic athletic competitions based on biological sex, passed in House Constitutional Rights and Remedies Committee.

2. Legislation providing additional property-tax relief for Texans.

**SB 1** relating to a temporary reduction in the maximum compressed tax rate of a school district and the form of the ballot proposition to be used in an election to approve a tax rate adopted by a school district that exceeds the district's voter-approval tax rate; making an appropriation, passed in the Senate and was heard in the House Committee but left pending.

# Bills cont.



3. Legislation similar to Senate Bill 474 as passed by 87th Legislature, Regular Session, but that addresses the concerns expressed in the governor's veto statement.

**SB 5** Relating to the unlawful restraint of a dog; creating a criminal offense. Passed in the Senate. Senator Blanco is a co-author of the bill. The bill passed in the House Committee.

4. Legislation proposing a constitutional amendment to further protect the safety of the community, law enforcement, and victims, from accused criminals who may be released on bail, including by giving magistrates the discretion to deny bail under some circumstances to people accused of certain violent, sexual, or trafficking offenses.

**SJR** 1 Proposing a constitutional amendment requiring a judge or magistrate to impose the least restrictive conditions of bail that may be necessary and authorizing the denial of bail under some circumstances to a person accused of a violent or sexual offense or of continuous trafficking of persons. This bill passed in the Senate and House Committee.

5. Legislation regarding whether any state or local governmental entities in Texas can mandate that an individual receive a COVID-19 vaccine and, if so, what exemptions should apply to such mandate.

6. Legislation providing appropriations from the American Rescue Plan Act of 2021 (ARPA), Pub. L. No. 1 17-2.

**SB 2** Relating to an appropriation of certain federal coronavirus relief money for paying down the state's unemployment insurance debt was left pending in the Senate Committee.

**SB 8** Relating to making appropriations of certain federal coronavirus relief money, was left pending in the Senate Committee.

**SB 8** Appropriates **\$16.3 B** from ARPA -- **\$15.8 B** from the Coronavirus State Fiscal Recovery Fund and another **\$500.5 M** from the Coronavirus Capital Projects Fund:

- \$7.2 B to replenish the Unemployment Compensation Fund
- **\$3 B to** deploy hospital surge staffing, purchase therapeutic drugs, and support regional infusion centers
- **\$3.7 B** to cover salaries and benefits for state employees directly working on pandemic response
- **\$500.5 M** for broadband expansion
- **\$500 M** for construction projects at institutions of higher education
- \$300 M for a State Operations Center to aid the state in disaster response
- \$200 M to bolster cybersecurity
- **\$160 M** to shore up funding for organizations serving sexual assault survivors and other crime victims
- \$286 M to the Teacher Retirement System to cover COVID-related health claims
- **\$237.8 M** for new state psychiatric hospital in Dallas
- \$113 M to the Texas Child Mental Health Care Consortium
- **\$100 M** to support Texas food banks

### RESOLUTION

WHEREAS, the Governor has convened a third special legislative session of the Texas 87<sup>th</sup> Legislature to consider legislation relating to the apportionment of the State of Texas into districts used to elect members of the Texas House of Representatives, the Texas Senate, the State Board of Education, and the United States House of Representatives, a process known as "redistricting"; and

WHEREAS, redistricting is the revision or replacement of existing electoral districts, resulting in new districts with different geographical boundaries in order to equalize population among electoral districts after publication of the United States decennial census indicates population has increased or decreased over the last decade; and

WHEREAS, the Texas Senate has proposed a redistricting map ("Map") that would remove Fort Bliss and the El Paso International Airport ("EPIA") from District 16, which is an El Paso-based congressional district and place these two vital economic drivers for our community and region in District 23, which is based in San Antonio; and

**WHEREAS,** if the proposed Map is approved, a significant portion of our City, including a portion of Northeast El Paso, Fort Bliss and the EPIA will be represented by a Congressional delegation member based over 550 miles away as opposed to a member based within the City, familiar with the needs and services of our City and its residents; and

WHEREAS, the El Paso International Airport, owned and operated by the City of El Paso, is a catalyst for growth and plays an important role in the strength and resilience of our region's economy; and

WHEREAS, the City of El Paso, has identified the continued growth and development of the El Paso International Airport as a key strategic objective, successfully engaging in publicprivate partnerships that result in the development of airport land, including the construction of a \$150 million distribution center, bringing 950 new jobs to the region, and generating over \$48 million in revenue to the Airport over the next 50 years; and

WHEREAS, \$3.3 billion of goods moved through the Airport's Foreign Trade Zone No. 68 and \$542 million of merchandize was exported from this Zone to other countries in 2020 alone, and further, Foreign Trade Zone No. 68 is directly responsible for 2,055 jobs; and

WHEREAS, with an average of 47 departures per day and an annual 3.5 million throughput in total passenger traffic, the airport facilitates tourism and provides local businesses with access to the global market; and WHEREAS, Fort Bliss has a \$4 billion impact on the local economy, directly employs over 47,000 people and indirectly employs another nearly 84,000, making Fort Bliss the single largest employer in the El Paso region, contributing to the livelihood of at least 1 in 5 people in El Paso; and

**WHEREAS,** in 2020, there were nearly 38,000 active duty family members that reside in the El Paso region where they live, work, and play, while an additional 3,000 soldiers released from active duty decided to make El Paso their permanent home; and

WHEREAS, the City of El Paso and Fort Bliss have a history of strong cooperation ensuring our shared community has access to the services critical to public safety, education, and quality of life; and

WHEREAS, drawing a district boundary that excludes the El Paso International Airport and Fort Bliss from being represented by a Congressional representative who is locally based and understands the needs of these key community assets and the critical role they play in the strength and resilience of our community;

### NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

The City Council of the City of El Paso urges the Texas 87<sup>th</sup> Legislature to support El Paso by ensuring Fort Bliss and the El Paso International Airport remain in Congressional District 16.
